**Spin 360 does not give refunds or transfers on any exercise program. 12 month agreement for Spinning must be met before any cancellations. Cancellations must be in writing to Spin 360 thirty (30) days prior to ending your program. All pre-paid sessions of the Personal Training program must be used within thirty (30) days unless agreed upon by the member and the trainer no refunds.**

Member hereby acknowledges that the weight-training machines and cycles are inherently dangerous if used in a non conforming manner. All safety rules are to be strictly adhered to. Member expressly waives liability of Spin 360 for any injury that occurs as a result of the exercise equipment used. Use of the facilities, services, or equipment is at the member's own risk. Spin 360 shall not be liable for damages for personal injuries on premises. Member releases Spin 360 from any claim, demand, or action arising from use of the Spin 360 facility without limitation, any claim for personal injuries resulting from the negligence of Spin 360.
